Notes

(1) GOC, formed in 1998 to manage residual land, assets and liabilities following the restructure of the electricity industry and trade all electricity generated by Queensland's privately owned generators. Constructed, owned and operated the \$150 million Moranbah to Townsville gas pipeline and processing plant. Annual turnover up to \$750 million. Sold to AGL and Arrow Energy in April 2008.

(2) Operating subsidiaries of Enertrade

(3) Established May 1984 and operating throughout Far North Queensland, growing to the largest Group Training business in Qld after 3 years and the third largest in Australia in 5 years. Founding Chairman, retired 8 years after establishment.

(4) QIDC was formed from 3 government departments in 1991 to become the State's bank, competing in the market with all banks and growing to a capital base of over \$3 billion. Merged with Suncorp and Metway Bank 1996.

(5) Subsidiary of QIDC with \$50 million capital to invest as venture capital in Queensland start up and immature businesses

(6) Subsidiary of the Cairns Chamber of Commerce to promote Cairns businesses to export markets and lead trade missions to Guam, China, PNG and Indonesia

(7) Now known as Queensland Chamber of Commerce & Industry Queensland. Queensland's peak employer association.

(8) One of Queensland's electricity retailers following the restructure of the state owned electricity. Merged with the Central Queensland retailer to form Ergon Energy

(9) GOC to promote North Queensland to export markets and to attract industry establishment.
